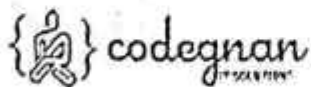

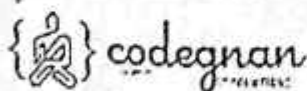

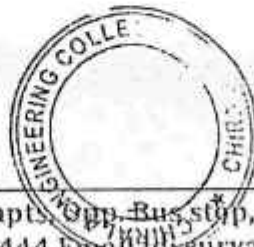

- i. TEPL may establish Research and Development cell with in the campus and encourage CECC to establish industry relations.



